# Filming Conditions FAQ

## Q: Do I need a permit to film in Westwood Village?

Yes, a film permit is required when the project has any commercial value.

## Q: How do I obtain a permit?

The City of Los Angeles contracts with FilmL.A. for permit coordination services for the City. Submit a film permit application directly on the FilmL.A. Online Permit System at www.filmla.com at least 5 business days before the first day of filming.

## Q: I've contacted FilmL.A. Who else am I required to contact?

Production companies are also required to contact the Westwood Village Improvement Association (WVIA). Please contact Marketing and Communications Manager, Megan Furey at (310) 470-1812 or megan@thewestwoodvillage.com

#### Q: Where can I film?

You can film on Broxton Avenue, Glendon Avenue, Gayley Avenue, Le Conte Avenue, Hilgard Avenue and Wilshire Boulevard during regular business hours. Regular business hours are defined as 10:00 a.m. to 9:00 p.m. Proposed filming planned for before or after hours are reviewed on a case-by-case basis.

Grid permits or roaming filming will be reviewed on a case-by-case basis and may require a FilmLA monitor.

If filming at the Westwood Village Farmers' Market (WVFM) on Thursdays, please contact market operator Mark Anderson at info@farmermark.com, 5 days prior to filming.

Filming activities that involve exteriors, the use of sidewalks, streets or parking facilities shall be prohibited on all National holidays. Filming activities that involve exteriors, the use of sidewalks, streets, or parking facilities will not be permitted for the two weeks preceding Christmas Day.

# Q: Is there a fee due to the WVIA for my filming within the Westwood Business Improvement District?

The Westwood Village Improvement Association is a California Nonprofit 501(c)3 charitable organization that works to make the Westwood Village District the best possible place to live, work, and play. The WVIA is pleased that you chose Westwood Village as the location for your filming or event.

Maintaining a clean and safe district requires significant resources and funding. While there is no fee for filming within our boundaries, the WVIA respectfully encourages you to make a contribution to help us keep our district welcoming and attractive, so it can remain a thriving and inviting place for everyone. #### Q: Where can we park during the film shoot?

Cars must park off-street in private facilities during filming. Cast and crew parking is not permitted on area streets or in the public parking structure on Broxton Avenue.

# Q: What signage am I required to post?

If the filming impacts the area surrounding the Broxton public parking structure, signage visible to drivers must state that this structure is open to the public.

Posting of "No Parking" signs (for parking equipment vehicles or for picture) should be kept to a minimum in order to reduce any negative impact on the local business community. Broxton Avenue has very little metered parking. Surveys may be required from both sides of this street depending on the impact to the businesses (requests will be evaluated on a case-by-case basis).
